UAE NEWS

- UAE is attracting an increasing flow of FDI, driven by several factors, among which a network of CEPA with global partners is significant: Abu Dhabi Investment Office.
- Emirates Steel Arkan logged net profits after tax valued at AED 128.22 million in Q1 of 2024, down YoY from AED 152.17 million. Revenues plummeted to AED 2.13 billion in Q1-24.
- Presight Al Holding recorded a consolidated net profit after tax of AED 95.94 million in Q1-2024, up from AED 72.40 million in the comparative period of 2023.
- ADNOC signed 15-year agreement with Germany's EnBW Energie Baden-Württemberg for delivery of 0.6 million metric tonnes p.a. of liquefied natural gas.
- Rak Properties posted lower net profits after tax at AED 41.45 million in Q1-24, compared to AED 44.60 million in Q1-23. Revenues rose to AED 289.81 million in Q1-24.
- ADNIC delivered a strong net profit before tax of AED 111.8 million for the Q1-24, underlining the company's robust financial performance & strategic growth initiatives.

- al Rajhi Bank announces commencement of the offer of its U.S. dollar denominated additional tier 1 capital sustainable sukuk under its international additional tier 1 capital Sukuk program.

GCC NEWS

- 🦐 Money in circulation in the Saudi economy surged 8.30% YoY to SAR 2.823 trillion in Mar2024 from SAR 2.60 trillion. Month-onmonth total liquidity grew 2.50% from SAR 2.75 trillion in Feb.
- ACWA Power Co. recorded a 9.80% annual increase to net profit to the equity holders at SAR 296.17 million during the first quarter (Q1) of 2024, compared with SAR 269.73 million.

COMMODITIES

- Sold prices ticked up on Friday and were on track for a weekly gain, as recent economic data prompted traders to raise bets of an interest rate cut from the Federal Reserve later this year.
- Oil prices rose on Friday, continuing upwards trend on the signs of improving economy in China and as negotiations to halt hostilities in M.E. yielded no results.

FOREX NEWS

- usd had a soft tone on Friday after losing ground overnight on back of U.S. data showing further signs of a cooling labour market & hence higher odds of Fed rate cuts this year.
- GBP had gained in the wake of the U.S. data, recovering from a low of \$1,2446, its weakest since April 24, after the Bank of England (BoE) paved the way for an interest rate cut.
