- Emirates Islamic Bank (EIB), rated A+ (stable) by Fitch, has issued mandates for a dollardenominated five-year benchmark Reg S senior unsecured sustainability-linked sukuk.
- ှ Global digital payments player Visa has launched Visa Private, an exclusive premium offering tailored for high-net-worth individuals, in the UAE before a wider reach in the region.
- Sharjah's real estate sector continues its remarkable growth, recording AED4.9 billion in property transactions during August 2025 - a 75.8% increase compared to August 2024.
- ALEC Holdings intends to list 20% of its share capital on the DFM through an initial public offering, with the IPO subscription period expected to run from 23 to 30 September 2025.
- Sharjah FDI Office has announced an increase in foreign direct investment during H1 of 2025, with capital investment soaring by 361% to \$1.5 billion, , up from \$325 million.
- Dubai-based carrier flydubai has entered into a strategic interline agreement with TAROM, Romania's flagship carrier, to increase its global reach.

ISLAMIC BANKING NEWS

- Mobile Telecommunication Company Saudi Arabia (Zain KSA) has secured an Islamic facility of 5.5 billion riyals (\$1.47 billion) from a group of local and regional banks.
- S&P Global Ratings assigned its 'BB-' issue rating to the \$400 million senior unsecured sukuk issued by Omniyat Holdings Limited.

GCC NEWS

- GCC banks are set to exceed USD60 billion of US dollar debt issuance in 2025, and USD40 billion excluding certificates of deposit, surpassing the record levels of 2024: Fitch Ratings.
- Saudi Arabian dairy firm Almarai Company, rated Baa3 Positive by Moody's and Baa- Positive by S&P, has mandated banks to issue dollar-denominated trust certificates.

COMMODITIES

- Gold prices scaled a record peak, supported by a weaker dollar ahead of the Federal Reserve's policy meeting this week, where the central bank is widely expected to cut borrowing rates.
- Oil prices edged up after rising in the previous session, as market participants contemplated potential supply disruption from Russia after Ukrainian drone attacks on its refineries.

FOREX NEWS

- USD traded near a 2-1/2 month low against the euro as investors cemented bets for a Federal Reserve interest rate cut this week and more to follow.
- CNY briefly revisited a more than 10-month high against USD before paring most of the gains, lifted by heightened expectations for a Federal Reserve interest rate cut.
