- RAKEZ recorded 23% increase in new business registrations during Q1-25, compared to 2024, with 3,676 new companies joining the emirate's thriving business community.
- Etihad Airways CEO says IPO decision is with its shareholder with many speculating that an announcement will be made this quarter. Airline to expand fleet to 170 aircraft by 2030.
- Dubai's tourism is experiencing significant growth, with visitors from Russian Federation & GCC demonstrating highest spending, followed by tourists from European nations.
- Oman continues to maintain its position as UAE's second largest trading partner in the GCC, & non-oil trade grew in 2024 to AED56.2 billion: 9.8% increase compared to 2023.
- Dubai-based developer Omniyat has set the yield for a \$500 million green sukuk at 8.375% following strong investor interest, with books over \$1.8 billion.
- ENOC Group reports strong 2024 performance across key business segments. ENOC opened 9 new service stations across the country in 2024.

ISLAMIC BANKING NEWS

Bank Albilad logged net profits after Zakat and tax valued at SAR 700.40 million in the first quarter (Q1) of 2025, up 8.90% year-on-year (YoY) from SAR 643.10 million. DMCC, Dubai, announced the appointment of a Shariah Supervisory Board to oversee its Islamic finance offering through its Tradeflow platform.

GCC NEWS

Bahrain is preparing to launch a bond sale to tap the international markets, as it seeks ways to refinance debt due to strained finances from lower oil prices. Sanabil Investments, a subsidiary of Saudi Arabia's PIF, is partly funding Middle East tech firm iMENA Group's \$135 million capital raise, which company said was first tranche of a planned IPO.

COMMODITIES

Gold fell as softening trade tensions between U.S. & its trading partners dulled the metal's safe-haven appeal, while investors awaited U.S. economic data to assess Fed Reserve's policy path. Crude oil prices fell as investors lowered their demand growth expectations due to the ongoing trade war between the United States and China, the world's two biggest economies.

FOREX NEWS

USD barely recovered its heavy losses as investors were still unsure if China-U.S. trade war was easing with Treasury Secretary suggesting burden on China to start negotiations. GBP traded steadily, heading for its strongest monthly performance against USD since late 2023, reflecting how much investors have punished U.S. assets in April.
